WHEREAS

- 1.  - 5. DC and PC will ensure quality training by employing qualified and eligible trainers.
 - 6. The Govt. rules will be followed in case of Fee and scholarship.
 - For effective implementation & monitoring of the scheme as envisaged in the MOU, there will be one Nodal Officer on behalf of DC, PC and one Nodal Office on behalf of Institution.
